NOTICE OF ENTRY

On March 25, 2009, the above-referenced case was entered on the docket of this court.

The appellant's brief and appendix must be filed **WITHIN FORTY DAYS OF THE ABOVE ENTRY DATE** and the appellee's brief within thirty days after service of the appellants' brief. All briefs and appendices must comply with the Massachusetts Rules of Appellate Procedure. Counsel and pro se litigants are reminded to reproduce the entire trial court docket sheet, the notice of appeal, and all relevant portions of the record below including, in civil cases, all necessary transcript pages. Appendix pages must be consecutively numbered and legible.

If you are an attorney admitted to practice in Massachusetts, you are **required** by Supreme Judicial Court Rule 1:08(1) to include your Board of Bar Overseers (BBO) number on all filings.

Counsel of record in this case are requested to register with the Appeals Court **E-NOTICE PROGRAM** by sending an email to enoticesignup@appct.state.ma.us indicating that you wish to receive court notices via email. For those counsel registering with the E-NOTICE PROGRAM, you are hereby advised that notice of scheduling of oral argument will only be sent electronically with no written notice to follow. You will be able to respond electronically to the notice.

NOTICE OF PILOT PROJECT The Appeals Court is joining with the Supreme Judicial Court in a pilot project to receive briefs and record appendices in electronic form, with a view ultimately to making them available to the bar and to the public. Counsel are

therefore invited to submit, in addition to the requisite number of briefs, appendices, transcripts, and exhibits required by Mass.R.A.P.18(e)(1),(2),(3) and Mass.R.A.P.19(b)(1),(2),(3), an electronically searchable PDF version of the brief (and record appendix if feasible) on a CD-ROM disk. In the alternative, counsel may submit a one-sided paper copy of the brief and the record appendix, both with white covers, temporarily held together with a clip or rubber band, but that is neither stapled nor otherwise bound, contains no dividers, bindings, nor tabs that require removal, and that can be readily scanned into the Clerk's electronic management system.
